Topic: 1. The assassination of John F. Kennedy

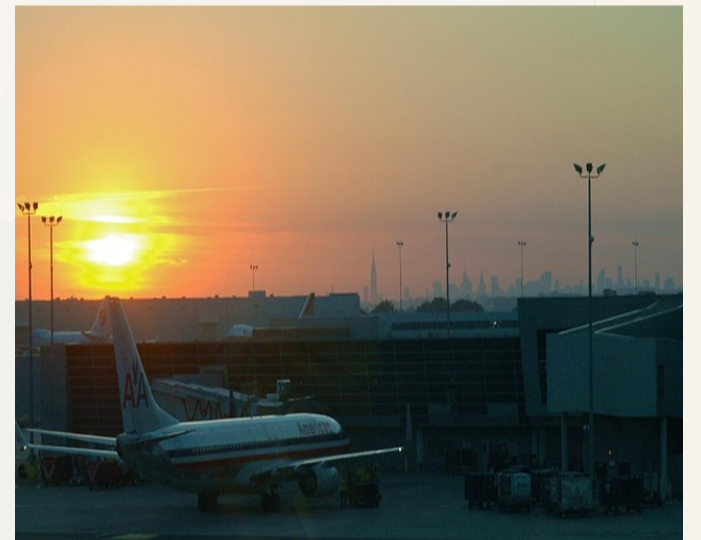
